Sou u later wens om die saak met ons te bespreek, sal ons dit in die lig van die dan heersende omstandighede oorweeg.

### **THE BOERE-AFRIKANER PEOPLE'S CLAIM FOR SELF-DETERMINATION**

The Boere-Afrikaner People's Council offered you the opportunity to commence with discussions regarding our people's rightful claim and entitlement to territorial self-determination. Apparently you decided to ignore our request to discuss this matter.

The history of nations and states demonstrates that issues like these do not vanish when rulers ignore them. Similarly our people's insistence for national freedom will not vanish; to the contrary, it will grow.

We hereby inform you that we shall now continue with the means to our disposal and in conformance with the rules of International Law to do whatever we find necessary to regain our people's national freedom.

Should you at a later stage wish to discuss the matter with us, we shall consider it in view of the then prevailing circumstances.
