TAKE NOTICE that the Boer-Afrikaner Volksraad (hereinafter called "the Applicant") intends to make application to this Court on _____ at 10h00 or as soon thereafter as the legal representative for the Applicant may be heard, for an order in the following terms:

1. That the First Respondent, in his capacity as Head of the national executive of the Republic of South Africa, is ordered to furnish the Applicant with written confirmation, signed by himself or by another person (duly authorised thereto) on behalf of himself and within 3 (THREE) calendar months from the date of this Order, as to:
 - 1.1 Whether the Government of the Republic of South Africa ("the Government") is willing to enter into negotiations with the Applicant regarding implementation of the concept of territorial self-determination for the Boer-Afrikaner people; or
 - 1.2 Whether the Government is not willing to enter into such negotiations with the Applicant; and
 - 1.3 If the Government should indeed be willing to enter into such negotiations with the Applicant – to confirm when it shall be able to commence therewith; and
 - 1.4 If the Government should not be willing to enter into such negotiations with the Applicant – the reason or reasons therefor.

- c) to deliver your answering affidavit, if any, together with any relevant documents within 15 (FIFTEEN) days after service of your aforesaid notice of intention to oppose this Application.
